## Blind Whino: Southwest's Newest Art Hub

The visual overhaul of the old Friendship Baptist Church on the corner of Delaware Ave and H St SW has Southwest residents excited. A group of artists assembled by Ian Callendar of SuiteNation and Shane Pomajambo, Executive Director of Art Whino, renovated the church in March 2013. Named Blind Whino, the space will be used for the G40 2013 Art Summit from September 13th - October 6th and will become the SW Arts Club thereafter. As plans to refurbish the Randall School building into a Bing Thom-designed modern art museum move forward, this corner of SW is primed to become a major arts hub in the city. Sam Marrero sat down with Callendar to get all the details.

**Q: How did you guys find out about the space? Whose idea was Blind Whino?**

*A: Shane Pomajambo, of Art Whino, connected with the owner of the property, who lives in the neighborhood, and created a unique concept to add some color to a once blank canvas. Blind Whino was a collaborative creation from both Shane and I as we attempted to develop a meaningful name for the project. The name Blind Whino was a combination. Whino stems from Shane's Art Whino Gallery, named best Gallery in Washington, DC five years in a Row by the City Paper. Blind Whino introduces the Speakeasy concept where people met to mix and mingle in places that were hidden, but not for long, as word got out of their existence. These places were destinations for art, jazz, and social gatherings. Perfect combination of culture and the arts!*



**Q: Friendship Baptist Church had apparently been vacant for two decades. Did you sense any resistance in your attempts to re-paint/refurbish it? Was the city cooperative?**

*A: We have received overwhelming support in our efforts to reactivate the 700 Delaware property from both the Southwest Community and the city collectively.*

**Q: What have been your impressions of Southwest since you've arrived? What is your vision for Southwest regarding**

**the arts community.**

*A: With Mera Rubell's Family Collection and Redevelopment coming to the old Randall School, this quadrant of Southwest is set to become a booming Arts District. It IS similar in story to the Wynwood Arts District in Miami. Most are unaware that Mera Rubell is one of the original founders of Art Basel in Miami, as well as the Wynwood Arts District. Still others are not aware that the Rubell Family is one of the world's top contemporary art collectors. Having them across the street from Blind Whino SW Arts Club can only mean that the art culture is destined to grow and thrive for years and years to come in the nation's capital. Further, the city has the potential to join other international cities as a major center for art, like Miami.*

**Q: Chris Bradshaw's nonprofit 'Dreaming Out Loud' has been micro-gardening on the grounds immediately outside the space. Have you met? Collaborated?**

*A: I think what he is doing is phenomenal with our youth. Finding nontraditional ways to give back to our community is always something special. We plan to work with his organization in some fashion to be determined in the future, as we are neighbors at 700 Delaware.*

**Q: How did these artists come to be the artists for the job? (Exterior [HENSE - ATL] and interior [MEGGS - AUS])**

*A: Shane handpicked these two amazing talents and offered*

## Town Center East Designated as a Historic Landmark

People matter. At times, the strong currents of history here in Southwest, such as "density near Metro," are balanced with other currents: honoring our heritage, respecting the quality of life of our diverse residents, both new and old, saving the vision of a genius.

Designed by I.M. Pei, Town Center East comprises twin towers at 1001 and 1101 3rd St SW and surrounding open spaces. While 1101 has been the Waterfront Tower condominium for a few years, 1001 is an apartment building and awaits updating. Both have been home to Southwest residents continuously since 1961. Pei, a world-renowned modernist architect, has designed iconic landmarks including the East Wing of the National Gallery and the Pyramid at the Louvre in Paris. In Town Center East (as well as Town Center West opposite Arena Stage), he employed an elegant yet simple balance of materials, a glass "skin" and poured cement frame, set on curved piloti and cantilevered at all four corners, giving the structures a unique grace. Residents particularly appreciate how well great architecture works from inside their homes: "the sense of being outside when inside because of the view-framing windows." Pei wanted to make life better for middle-income residents with adequate light and air surrounding the buildings. With the glass walls, even small rooms lose their walled-in feeling. Sunrise,



clouds, rainstorms, a full moon - all become part of daily existence.

On June 27th, 2013, fifty-two years after Town Center East was completed, the DC Historic Preservation Review Board (HPRB) voted unanimously to approve an application to recognize Town Center East as a historic landmark. The application was co-sponsored by the owners of Waterfront Tower condominium (WFT) and the Southwest Neighborhood Assembly (SWNA). As a historic landmark, Town Center East takes its place in the District of Columbia Inventory of Historic Sites, alongside Harbour Square, Tiber Island, Potomac Place Tower, Arena Stage, and other Southwest landmarks. HPRB further recommended that Town Center East's nomination be forwarded to the National Register of Historic Places with a recommendation for listing at the national level of significance.

The HPRB report found that Town Center East merited designation under National Registry criteria of "architecture and urbanism," "creative masters," and "history." They concluded it is "one of the earliest and most distinguished components of the Southwest Redevelopment Area, one of the most extensive and thorough urban renewal efforts in the nation." The sponsors were pleased to hear the HPRB reaffirm the importance of light and space in the development, noting, "I.M. Pei has always stressed the importance of the provision and handling of light, and to this end, and to provide sufficient recreation space for ... (over 200) ... apartments, the courtyard was made wider than the heights of the buildings."

How was this nomination process that often takes five months completed in six weeks? First, with continuous strong backing from its co-sponsors: the WFT condominium board and the Assembly. Second, with the focused efforts of architectural historian, Peter Sefton, who had also prepared the successful nominations for Tiber Island and Harbour Square, as well as the Pei-designed Slayton house in Northwest DC. And also, with the photographic efforts of Madeline Clites, a new Southwest resident.

The Assembly and members of the city's historic preservation office gave presentations to TCE residents on the impacts of historic



## The Dog and the DEA

What is the Dog DEA? Is it a new government program? Not exactly, DEA in this instance stands for Dog Exercise Area. This is a securely fenced area where dog owners can bring their dog for exercise and socialization. Individual owners are responsible for cleaning up after their dogs. The sponsoring group maintains the overall cleanliness of the Exercise Area weekly.

Dogs, similar to children, have lots of energy and need to have structured exercise to maintain their health. This was part of the motivation behind creating the dog park regulations in 1997. The dog park regulations were issued which allowed for the creation of official, public dog parks on District-owned parkland. Before 1997 there were no legal off-leash dog parks.

DC Parks and Recreation operates 12 off-leash dog exercise areas in District. Nine of these 12 parks are located in the NW quadrant. SW doesn't have a dog exercise area just yet. Off-leash exercise areas are the only areas in the district where dogs can be off leash. DC's leash laws state that all dogs must be on a leash and under control of their handler when in public.

The Paws of SW Dog Park Group has been working with the DPR for the past two and half years to plan, apply for, and implement the first Dog Exercise Area in the SW quadrant. The Dog Exercise Area for SW has been approved and, in addition to the new basketball courts and community garden, will be a wonderful asset for the community to enjoy at Lansburgh Park. Even if you don't own a dog you can still come out and observe dog behavior at the exercise area. Bringing children to observe the dogs safely (from outside the fence) is an excellent way to allow children to understand dog behavior without having to interact directly with the dogs.

A well-exercised dog is a happier dog. Dogs that receive adequate exercise tend to bark less, and are calmer. Having a place for the dogs to exercise off-leash will not only make the dogs happier, it will make the neighbors happier. Paws of SW Dog Park Group will maintain the cleanliness of the park to ensure the health and safety of the community and dogs.



# Water the Trees: The ANC 6D Report

The District Department of Transportation Urban Forestry Administration asked us all to water the newly planted street trees in Southwest and Southeast. DC planted them along the streets, and the trees have green plastic watering bags around them. Water can be added by pouring it in slits under the labels at the top of the green bags. The two trees on I St, near the Amidon school new play equipment had empty bags on July 8th, the evening of the meeting. Andy Litsky, chair of the Advisory Neighborhood Commission 6D (ANC) announced the plea for water at the ANC meeting. He said to water them, "otherwise the trees are going to die a slow and painful death."

Matt Stenboek, representing The Wharf development, announced that final negotiations are going on with the equity partners for the Wharf development project. The project thinks that in 90 to 120 days, in November or December, they will have the final permits and the financing. The construction will take about 42 months.

The Fish Market will get a new street intersection, so they can continue operating during construction. Space will be found for Jenny's restaurant and the Capitol Yacht Club, so they can continue operating. The Kastles tennis team will play through their season. The Channel Inn and Phillips will close a month before the financing is settled.

Clark Corporation has been chosen for the design build contract. Ron McBee said, "Clark has a record in our community that is not great. I go by a Clark employment office on 7<sup>th</sup> and Q St NW. I would like you to ask them to have an office like that here." He also asked about activities in the area of the Wharf. The planned activities will continue through the summer.

Kael Anderson, President of the Southwest Neighborhood Assembly, said the proposed Public Information Display in the Safeway window needs help from the ANC. "We have been talking about the project for two years and the District of Columbia Department of Transportation just sits on their hands." Charles Allen, Chief of Staff for Tommy Wells, Ward 6 City Councilman, said to the commissioners, "Put together a resolution that clarifies the importance for the community." Ron McBee said he would write it and Andy Litsky would sign it.

The people won another battle against a developer on June 27th, when the Historic Preservation Review Board voted unanimously to designate Town Center East as a historic landmark, as the ANC recommended last month. Town Center East consists of the two apartment buildings

designed under the direction of I.M. Pei at M and 3<sup>rd</sup> St SW. They will be entered into the DC Inventory of Historic Places. The Board's resolution includes the air and space between the buildings. The resolution will be forwarded to the National Register of Historic Places.

Kael Anderson and the developer met with the Historic Preservation Board. The board said that the original design of the new development was off-center and inconsistent with the surrounding properties. The developer will present again to the Historic Preservation Board in August. The hearings before the DC Inventory of Historic Sites and the Zoning Board will take place in September. The Planned Unit Development application may be heard by the ANC in September, also. Andy Litsky said, "We will be looking at it with new eyes, since the buildings have historic designation."

Rhonda Hamilton will write a letter to the DC Department of Transportation about tour bus traffic on residential streets in Southwest. The Department of Transportation agreed to post signs when the ballpark was proposed, but they have not followed through. The Commission voted unanimously to send such a letter.

The architect for a proposed 13-story apartment building at 82 I St SE proposed a curb cut for the building at the northeast corner of the building. The land was originally granted to the railroad, when the railroad was developed. They have the right to build to the street line, but the first and second floors of the apartment building will be set back 12 feet, for sidewalks and trees.

them a rare opportunity to paint in the nation's capital. These artists are well regarded and their stature is growing in the art world. They loved the opportunity to add their creativity to our project. They considered it an honor to paint in Washington, DC, a mere 4 blocks to the US Capitol Building.

**Q: What flavor of events programming can we expect from SuiteNation? Suits & ties? Hip Hop & dancing? Sipping wine and chatting in front of art? DIY spray-paint parties?**

landmarking efforts. By the time of the hearing, residents submitted dozens of endorsement statements and packed two ANC 6D meetings. As a result, ANC 6D unanimously endorsed the historic landmark application on June 10th, and Chairman Andy Litsky, Commissioner Roger Moffatt, and Commissioner Ron McBee testified before the HPRB.

Recognizing the importance of the property, the broader community also rallied, from Ward 6 DC Councilmember Tommy Wells, Richard Longstreth (Director of GWU's Historic Preservation Program), Arena Stage architects Bing Thom & Michael Heeney, Gregory Hunt (Dean, Marywood School of Architecture), Eric Jenkins, (Professor, Catholic University School of Architecture), the DC Preservation League, the Fourth Street Neighborhood Group, as well as many neighborhood residential associations. Perhaps most exciting to the architects involved in the effort was the letter from Henry Cobb, of Pei Cobb Freed & Partners. As a senior partner at I.M. Pei's successor firm, he wrote "to support the nominator's assertion that the central courtyard and flanking parking lots are essential to the integrity of Town Center East as a work of architecture and urban design."

This comprehensive effort proved that people can, and do, matter. Yes, the HPRB's endorsement affirms the significance of Southwest in the architecture, urban design, and social history of DC and the nation. Yes, a modernist masterpiece will enrich future generations. And yes, the diverse owners and residents of Town Center East will have preserved the Pei dream, while living it.

## Summer Fun at Randall Recreation Center

Step Dancing anyone? Yoga, board-games, a computer room, arts and crafts, and more are now available at Randall Recreation Center, which opened for summer activities for Southwest youth on July 1st. The program will run Monday through Friday from 4:30 to 8:30 until August 23<sup>rd</sup>. With support from the SW community, Sasha Bruce has placed three staff members, led by Courtney Gibbs, at the long closed Randall Site. It is hoped that the summer program for youth will be the first step towards broader programming at the site.

The start-up program, now in its first weeks, is taking hold. Youth enticed to the site for lunch snacks, donated by DC Central Kitchen, soon find that they can participate in chess class, join a step dance group, enter a impromptu contest on entice youth hooping, play cards and UNO, and sign up for planned arts classes. In the first two weeks about 14 young people attend daily, with an average of 20 to 25 showing up each day.

Volunteers are needed to register youth for classes, assist staff, play games, work with young children who are brought in while older siblings attend groups, and to run additional activities. We are also looking for Zumba teachers.

Plans are underway for expansion of programming in the fall. Envisioned are arts programming, groups and activities for young parents and families, adults and seniors to make Randall a center for community cultural and recreational life and a place for bridging the diverse groups in the neighborhood.

The Randall Center's reopening is due in large measure to the ongoing push from the Southwest Joint Randall Advisory Board, and the Community Benefits Coordinating

Council's Enrichment Committee, which set reopening Randall as a priority.

The project, now a joint effort of Community Benefits Coordinating Council, the SWNA Youth Activities Task Force, and Sasha Bruce Youthwork with strong support from Telesis/Rubell and Councilman Tommy Wells, has secured a series of grants supporting staff and activities this summer.



Special thanks are due to Marilyn Melkonian and Mera Rubell of Telesis/Rubell who started the fundraising with a \$5,000 grant. We are grateful also to developer Steve Tanner, owner of the painted church, who contributed \$5,000 for arts classes at the Randall Center, to start in late summer, organized by Art Whino's leader, Shane Pomajambo. Area churches have added similar support with funds from Westminster Presbyterian Church for its \$1,000; St. Matthews Lutheran Church for its contribution of \$1,800 remaining from a joint church summer program; \$1,000 from The Youth Activities Task Force, and a contribution of \$800 to the SWNA Technology Task Force enabling Perry Klein and his team to install a computer center at Randall. Additional grant applications are outstanding.

"I challenge myself in everything I do, and I just hope to go even higher and one day become a supervisor at Nationals Park."

Lawson and her colleagues provide a vital link between the Nationals and the nearby community. Bound to deepen over time, this linkage will provide the team new and exciting opportunities to improve the lives of Southwest residents.

## July Community Meeting: Be Careful What You Wish For

During July's community meeting keynote speaker Marc Weiss explained how a series of community development projects that the Southwest Neighborhood Assembly undertook led to not only a revitalized Southwest, but also a revitalized city. He reviewed how in 1998, the Assembly gained control of the eminently historic Syphax School. Then in a ground-breaking agreement, created an affordable housing village on a former toxic junkyard and refurbished the school. He discussed what, at the time, was the ground-breaking approach of shuttering an enclosed shopping mall and re-opening a formerly closed street to create Waterfront Station. And, of course, he conveyed how the Assembly set the groundwork for a billion-dollar waterfront rivaling Baltimore's Inner Harbor. All this in what was then an area that many Washingtonians didn't know of with the exception of a relative handful who visited Southwest's hidden gems like the Maine Ave Fish Market or the Market Inn.

Sometimes the solution was found by opening up a dialogue. For example, the Assembly found

success in promoting the benefits of Southwest when Arena Stage was planning to decamp to Northwest, rather than doubling-down in Southwest. Other times it was the more heavy-handed tactic of paying a law firm \$500 to explore suing the EPA for moving out of Southwest.

It was equally captivating to hear how these strategies were successful at other levels. Marc moved on to develop the Hope VI program at U.S. HUD and take the leading role in city's economic development office. At the city, he birthed former Mayor Fenty's residential-based development model and the Anacostia Waterfront Initiative: both of which we're seeing the fruits of today.

Throughout the evening, he nonetheless provided cautionary advice. Pursued to their ultimate extension without mitigating measures, these development models price out long-standing residents, reduce diversity, and subsume community heritage. He concluded offering pro bono counsel to the Assembly and advice to the community. Noting that few neighborhoods can match Southwest's rich diversity and heritage, he invited a number of strategies to publicize and promote our unique assets.


